Pass in +2/HSC/VHSE or its equivalent qualifying with minimum of 50% aggregative marks for

physics, chemistry and biology. The age for admission shall be 17years on or before 31st

December of the year of admission (as per university norms). All other norms of the admissions

as per the policies of Pharmacy Council of India, Government and Kerala University of Health

Sciences.

other Examination with Physics, Chemistry & Biology /Mathematics/Computer Science /

Biotechnology as optional subjects approved as equivalent to any of the above

examinations by the Kerala University of Health Sciences

Minimum qualification for admission directly to second year of the B. Pharm course (Lateral

admission)

1. A candidate who has passed the Diploma in Pharmacy course of Educational Regulations

1991 under Pharmacy act 1948 from an institution approved by the Pharmacy Council of

India with a minimum of 50% marks in the final year examinations.

APPLICATION PROCEDURE

1. Application fee once paid will not be refunded.

2. The candidate should possess good health and character

3. Copies of all certificated should be enclosed and attested by the Gazette officer once

submitted will not be returned.

4. Applications incomplete in all respects are liable to be rejected summarily without further

intimation Documents /certificates furnished after submission of the application will not be entertained under any circumstances. No opportunity will be given to incorporate any

5. The candidate is expected to ascertain his/her eligibility.

6. The candidate called for interview should bring all the certificate in original and the same

should be submitted to the institution at the time of admission.

SELECTION OF STUDENTS

The Selection of students for the B. Pharm course shall be made based strictly on merit as decided by the competent authority approved by the Government of Kerala/Kerala University of Health Sciences and as per guidelines of the Pharmacy Council of India.

Basic details of information about our institution for CAP 2020 had been communicated to CEE to admit 30 No's of Govt. Merit Quota seats.

REGISTRATION

A candidate on admission to the B. Pharm course shall apply to the University for Registration.

- 1. By making a formal application in the prescribed format.
- 2. Original degree certificate and mark lists of qualifying examination.
- 3. Allotment letter from the competent authority.
- 4. Eligibility and migration certificate wherever needed.
- 5. Original SSLC/equivalent certificate.
- 6. The fees prescribed for the course.

B. PHARM DEGREE COURSES

The program of study leads to a B. Pharm Degree offered by Kerala University of Health Sciences, Thrissur. The candidates who opt for B. Pharm are necessarily required to process high motivation towards Pharmacy profession. They should process special qualities of a spirit of humanity commitment and dedication to work and high level of maturity other than the academic requirements expected to be full filled.

DURATION OF COURSE

The course of study for B. Pharm shall be for a period of four academic years for those admitted to the First year B. Pharm course. Direct admission of Diploma in Pharmacy holders to the second year B. Pharm course is subjected to the ceiling of approved strength of the first year course by the Pharmacy Council of India and All India Council for Technical Education. For those admitted directly to the second year, the course of study for B. Pharm course shall be for a minimum period of three academic years. Each academic year consists of minimum 180 working days. Medium of instruction shall be in English

ELIGIBILITY FOR APPEARING FOR EXAMINATIONS

1. Attendance, progress and condonation option

A candidate should secure 80% attendance in theory and practical subjects separately to appear for university examination. Only students with 70% and above attendance are eligible for condonation. Condonation for shortage of attendance shall be vested with a committee constituted by the Principal/ Head of the respective college as the Chairman and five members (senior teachers) in the committee. The benefit of condonation will be available to the students only once during the entire course.

2. Internal Assessment marks

Theory: Three sessional examinations (evenly placed) shall be conducted during the academic year. The average marks of best two examinations shall be computed out of a maximum of 50 marks and constitute the sessional marks in theory.

Practical: Students are expected to perform the number of experiments listed in the respective syllabus. Students are required to maintain practical records for each of the practical subjects and should be produced at the time of practical examination to be certified by the external examiner. The maximum marks awarded for practical sessional is 50, out of which 30 marks shall be awarded for practical exercises and 20 marks for practical sessional examination conducted at the end of the academic year. Marks shall be awarded out of maximum of 10 to each of the practical exercises and an average of these shall be computed out of a maximum of 30 marks. While awarding the sessional marks for practical experiments, the following consideration should be taken in to account. Marks for practical experiments shall be awarded on the basis of preparedness of the candidate, manipulative skill, results, knowledge of the experiments, regularity in recording the reports and viva-voce A regular record of theory and practical sessional marks shall be maintained for each student in the institution. Improvement of sessional marks, Candidates who wish to improve the theory sessional marks can do by writing special sessional examination before the University examination. Only those candidates who have appeared for at least two regular sessional in theory are eligible to take up the improvement examinations. Such improvement is allowed for a maximum of two times for a particular subject. The improvement of sessional marks will not be permitted for practicals.

COURSE OUTLINE

The B.Pharm course is of four years duration, with University examinations at the end of each semester and includes one month internship/practical training and industrial visit.

INTERNSHIP

Every candidate shall undergo practical training in a Pharmaceutical manufacturing unit / a Hospital with at least three specialties / National research laboratory for a period of not less than 30 days (150 hours) after third year B. Pharm or fourth year B. Pharm. B Pharm degree will be awarded only after the training certificate from the training institute of having undergone the training successfully, is forwarded to the university by the Principal/Head of the department.

INDUSTRIAL VISIT

Students of fourth B Pharm course should visit some pharmaceutical manufacturing units or national research laboratories as a supplement to the academic training and submit a report to the satisfaction of the Head of institution.

CRITERIA FOR PASS

Candidate who has secured a minimum of 50% marks in the University examination (theory and practical separately) and 50% marks in Total (aggregate of marks in University examination and Sessional examination) for theory and practical separately in any subject or subjects shall be declared to have passed in that subject / subjects and exempted from appearing in subsequent examination. A subject includes both theory/practical if those subjects are having a practical examination. Candidate who fails in theory or practical examination in any subject need to appear only for the theory or the practical examination in which the candidate has failed.

CRITERIA FOR PROMOTION

Candidates who have registered for the university examination of a class will be eligible for promotion to the next higher class. Candidates with 80% attendance in theory and practical separately shall register for the exam in the concerned year. Only registered candidates will be eligible for attending the next higher class. For registering for third B. Pharm, the candidate should have passed in all subjects of First B. Pharm and for registering for final B. Pharm examination the candidate should have passed in all subjects of Second B. Pharm. The maximum time allotted for completion of course is 8 years.

FACILITIES AND GENERAL INFORMATION

- 1. Extensive library service together with systematic use of audio visual aids is available to help the students in their learning process. They shall follow the rules of library.
- 2. Extracurricular activities: In view of the main aim of the education as the all round development of the person, a number of opportunities are provided for the students to develop their skill and talents on various levels, such as membership to the student

- and participation of local, State and National Conference and exhibitions which promote, leadership potentialities in the students. Besides these opportunities to develop talents in music, dance, indoor and outdoor games and sports will be provided.
- 3. Vacation: Vacation is planned according to the programme of the course. If the Student are unable to return on time due to illness, it should be informed immediately to the principal, followed by written explanation. On return they should submit medical certificate issued by registered medical practitioner stating full particulars of their illness and treatment. Normally no other leave will be granted. Students are not granted leave for social events in the family. In case a student absent himself/herself from duty/class for any reason and the Principal is not satisfied of the explanation regarding her absence the student will be asked to make up for the number of days he/she was absent at the rate of one week for a day of absence provided it is approved by the principal.
- 4. Withdrawal and Agreement: Students will not be relieved during the course or during the compulsory service. If any student after admission to the course decided to withdraw voluntary form the college at any time before completing the course or during the compulsory service he/she will have to pay all fees. The student will be relieved from the college and certificates and marks card handed over to the student only after the obligation to the college is full filled. The college reserves the right to terminate anyone whose work or conduct is not satisfaction or for any other cause during the period of course.
- 5. Graduation: On successful completion of B PHARM programme the graduates is awarded B. PHARM degree during the university convocation. Transcript and course completion certificates are given only when the graduates meets all the course requirement of the college. Graduates are expected to register themselves with the Kerala Pharmacy Council.
- 6. When false statement in the application is discovered after admission has been granted, the admission will be cancelled, and fees will not be refunded at any cause.
- 7. Incomplete application will be rejected without any notice.
- 8. The application form should be filled in block letters, neatly, and correctly and to be submitted with required enclosures.
- 9. Do not send any original certificates along with application.
- 10. All candidates from India or abroad having qualification other than the 2 year PUC

- examination of the Pre University education board of kerala State, Should obtain an Eligibility certificate from the Kerala University in order to register for the course if selected.
- 11. If any candidates discontinue the course he/she must be paid all the course fee to the college.
- 12. Class will commence as per the schedule of University. Admitted candidates must attend the classes from the day of opening.
- 13. Registration to the course is provisional until the university declares the candidates is eligible
- 14. The students should claim the refundable deposits within three months of completing their course, failing which the deposits would be forfeited by the institution.
- 15. University fee is subject to change as per notification.
- 16. University Examination fee remitted will be in appropriate time as per the University notification.
- 17. The cost of any damage to hostel property will have to paid by the hostlers.

THE REGULATIONS INCLUDE IN THE FOLLOWING SECTION ARE NOT EXHAUSTIVE

- Students, whose conduct or attendance or progress is not satisfactory, will not be allowed to appear for University Examinations. They are also liable to be asked to leave the College.
- 2. Attendance at courses in Human formation, including medical ethics rural orientation programmes and behavioral Science arranged by the College is compulsory.
- 3. In case of non- attendance at classes an application must be presented to the principal for leave of absence giving the reason.
- 4. Students must maintain a sense of discipline inside the College and in its associated Institution and in public places. "Ragging "IS STRICTLY PROHIBITED. Students should refrain from disfiguring walls and furniture and from other objectionable practices.
- 5. Students are required to carry their valid identity cards at all time in the campus.

GENERAL DISCIPLINE

- 1. Students should be regular and punctual in the classes.
- 2. Students shall avail; only ten days of leave on medical grounds in an academic year that should compensate.
- 3. The students shall strictly follow the existing rules and regulations as well as the same implemented by the Institution from time to time.
- 4. Ragging is strictly prohibited. If anybody encourage or involved in ragging, will be terminated without any excuse. Further they will be prosecuted as per the existing law.
- 5. Students should refrain from defacing and damaging college property.
- 6. In case of breakage /loss of college property they shall be made good promptly, either individually or collectively.
- 7. The management has the right to expel any student whose conduct and character are not satisfactory.
- 8. Students must be regular and punctual in lectures demonstrations, seminars, practical, field work and such academic exercises. They are required to attend all the allotted working periods in each of the prescribed subjects. If so recommended by the respective Head of departments the principal is permitted under the regulations of university to countdown shortage of class attendance up to 10% caused by illness and such other valid reasons.
